**Iqaluit, NU** – Havaktiuyukhaq Nutaqqanut Inuulrammiinullu Havakvinga (RCYO) tunngahuktittiyuq Jane Bates nutaaq Havaktiuyukhaq Nutaqqanut Inuulrammiinullu (Havaktiuyukhaq). Bates tikkuqaqtuuyuq Havaktiuyukhaq auyalihaaliqtilluni Kamisinauyumit Nunavunmit pitquyauninnganik Maligaliurvikmit Nunavunmi, taimaa tallimanik ukiunik havaariyakhaa.

“Iilitariyara akhuurutiuyuq havaaq taimaa Havaktiuyukhaq,” uqaqtuq Bates. “Quviagiya pivihaqautikhaq ikayuriami angikliyumiriami nipingit inuulrammiit nunavunmi naunairiami nakuutqiangit piimayanginnik piyait, inmikkut atauttikullu.”

Bates ilauyuq RCYO qauyimadjutinga piqaqpiqtuq ikayuriami nakuutqiamik piimayanginnik inuulrammiit ilangillu. Pihimayaa Naunaitkutariniq Ulaasiliqinirmut naunaitkutinga Ryerson Iliharvikyuanganit, pilihaaliqtaa ayuittiaqtuq havaanga ilanginnut ulaasiliqiyii uumunnga Peel Nutaaqat Ikayuqniqmut Katimayiingit. Bates talvannga nuuttuq Yukon-mut, talvani havaktuq amihumik angayukhiq havaanga inuulrammiinut ilanginnullu ikayuutikhaq, taimaa utiffaarmat Ontario-mut. Bates piqaqtuq ayuittiaqtumik iliharniq ayuitaminiklu nutaaqanik hapummiutiniq, ilangillu ikayuutikhaq, inuulrammiit ihuarhainiq, qilamtuqutaliqqat nutqaqtittiniarniq, mamihainiqmut nunallaat katimaniq, unalu qayangnaqtumik pipkaidjutimut ihivriunniq.
